#### 6. **PRESIDENT'S COMMENTS**:

## **President, Comrade James Simpson**

As most members are probably aware, we raised our bar prices on February 1st. We had to do this because of the big jump in minimum wages legislated by the Ontario Government that came into effect on January 1. This was right after the regular smaller raise on October 1. Had we not acted, those raises would have had a profound effect on our Branch in that after several years of financial losses and just when we are close to breaking even, we are hit with these additional costs. We have calculated that the additional labour costs to the Branch in this year will be over \$8,000 so we had no alternative but to try to raise our revenues to maintain a break-even position.

We have limited the increases to the minimum we think we will need to try to maintain our break-even position. We are confident that after other bars and restaurants have raised their prices you will find that Strathcona prices are lower than what you can get elsewhere. It is worthwhile reminding everyone that our prices include HST while everywhere else it is added on.

The \$4,000 loss in January that Comrade Dennis has just reported is a step backwards but that was primarily due to a low level of activity in the Branch that month.

Another way to increase our revenues is to try to increase the use of the Branch and since many appeals to our members for attendance and participation have had limited success, we are going to try to increase our hall rental business by drastically reducing the rental rates if the renter uses our bar.

Near the end of today's Agenda, I will be tabling a Motion to end Strathcona's membership in the Ottawa Poppy Trust Fund. This action was discussed and approved at the January Executive meeting, with one member abstaining. There are many reasons for this and you will be made aware of them in an upcoming Newsletter. You will also hear them when the Motion is debated and voted upon at the next General meeting in April. According to the OPF Constitution when a fund member proposes to leave the fund the other members can be invited to the meeting when the Motion is to be discussed and to take part in the debate. This invitation has already been extended to the only other member of the fund, which is Westboro Branch. The General meeting on April 24 also happens to be our Election meeting.
